COVID-19

The guidelines we follow are provided by the <u>Centers for Disease Control and Prevention (CDC)</u> and the <u>Florida Department of Health</u> and will be followed at both of our locations in Brandon and Citra. These guidelines represent steps we can all take to reduce risk for ourselves and each other. We have provided alcohol-based hand sanitizers, cleaning sprays and wipes throughout our facilities, to clean and disinfect frequently touched objects and surfaces. In addition, deep professional cleaning of our facilities are taking place on a regular basis.

To ensure the continuity of services for our patients, we are constantly monitoring the prevalence of this virus in and around our communities and implementing precautions that will help keep our facilities as safe and healthy as possible. Therefore, we have suspended visitation of any kind including family, loved ones and any other outside visitors at both locations in Brandon and Citra until further notice.

At our Outpatient programs in Brandon we will continue to serve our current patients and accept new patients by offering telemedicine beginning this week.

At our residential program in Citra we are suspending admissions effective immediately to further ensure the safety of current patients, as well as our staff at this location. We will continue to evaluate the situation.

We are committed to protecting our patients, families, partners, employees and the community overall to fulfill our mission of healing individuals, families, and communities challenged by substance use disorders and related mental health conditions. National Drug & Alcohol Facts Week

SHATTER THE MYTHS

In it's 10th year, National Drug and Alcohol Facts Week® (NDAFW) is a health observance week for teens that aims to SHATTER THE MYTHS® about drug and alcohol use.



NDAFW® links students with scientists and other experts to counteract the myths about drugs and alcohol that teens get from the internet, social media, TV, movies, music, or from friends. It was launched in 2010 by scientists at the National Institute on Drug Abuse (NIDA) to stimulate educational events in communities so teens can learn what science has taught us about drug use and addiction. The National Institute of Alcohol Abuse and Alcoholism became a partner in 2016, and alcohol has been added as a topic area for the week. NIDA and NIAAA are part of the National Institutes of Health. Our outreach has grown considerably in the past ten years, reaching countries all over the world.

NDAFW® is an opportunity for teens, scientists and other experts to come together to discuss how drugs affect the brain, body, and behaviors, in community and school events all over America.
